### **III. APPROVAL OF MINUTES**

#### **SBA Quarterly Meeting Minutes for September 28, 2015**

Upon a motion by Mr. Tom Lange, with a second by Mr. Steve Burton, the Authority voted to approve the School Building Authority's September 28, 2015 Quarterly Minutes.

### **IV. EXECUTIVE DIRECTOR'S REPORTS**

#### **Executive Session**

Chairman Markham recognized Mr. David Sneed who requested that the Authority go into Executive Session to discuss legal matters.

Upon a motion by Mr. Steve Burton, with a second by Mr. Victor Gabriel, and based on the provisions of West Virginia Code §6-9A-4 an Executive Session was approved by the Authority.

There was no action taken in the Executive Session.

### **V. OLD BUSINESS**

#### **A. Reconsideration of Authority's Action on Fayette County CEFPA Amendment**

Mr. David Sneed informed the Authority that Mr. Terry George, Superintendent of Fayette County Schools, had requested that the Authority reconsider the Fayette County CEFPA Amendment that was presented to the Authority during the September 28, 2015 Quarterly Meeting. Mr. Sneed advised a successful motion on this issue would permit the Authority to reconsider its action on Fayette County's requested CEFPA Amendment.

Upon a motion by Mr. Steve Burton, with a second by Mr. Tom Lange, the Authority approved reconsidering its September 28, 2015 action on the Fayette County CEFPA Amendment.

**B. Reconsideration of the Fayette County CEFP Amendment**

The Fayette County Board of Education requested approval of an amendment to its 2010-2020 CEFP. This amendment for Fayette County includes the construction of a new 9-12 high school to accommodate the closure of Fayetteville High School, Meadow Bridge High School, Midland Trail High School, and Oak Hill High School and the consolidation/merger of these students into a new 9-12 school. The requested amendment would also include:

The renovation/reconfiguration of Fayetteville High School to accommodate the closure of Fayetteville Elementary School, Gatewood Elementary School and Fayette High School and the consolidation/merger of Fayetteville Elementary School (grades PreK-6); Gatewood Elementary School (grades K-4) and Fayetteville High School (grades 7-8) in a Fayetteville area school (grades PreK-8).

The renovation/reconfiguration of Meadow Bridge Elementary School and sections of the Meadow Bridge High School buildings to accommodate the closure of Meadow Bridge High School and the consolidation/merger of Meadow Bridge Elementary School (grades PreK-6) and Meadow Bridge High School (grades 7-8) in a Meadow Bridge area school (grades PreK-8).

The renovation/reconfiguration of Midland Trail High School building to accommodate the closure of Ansted Elementary School, Divide Elementary School and Ansted Middle School and consolidation/merger of Ansted Elementary School (grades PreK-5), Divide Elementary School (grades PreK-5) and Ansted Middle School (grades 6-8) in a Midland Trail area school (grades PreK-8).

The renovation/reconfiguration of the Oak Hill High School building to accommodate the closure of Collins Middle School and to serve as an Oak Hill area middle school (grades 5-8) replacing the current Collins Middle School (grades 5-8).

Upon a motion by Mr. Steve Burton, with a second by Mr. Tom Lange, the Authority voted to approve the amendment to Fayette County's CEFP.

**VI. CEFP AMENDMENTS**

Mr. Sneed advised the Authority that the following amendments to county Comprehensive Educational Facilities Plans (CEFPs) had been reviewed and were recommended for approval by the staff of the SBA and also reviewed and coordinated with the State Department of Education Office of School Facilities. The State Board of Education had/or will take action on these same amendments before the December Funding Cycle. For amendments relating to 2016 NEEDs Projects, approval of the amendments does not indicate financial support for these projects. Complete amendment submittals were made available to Authority Members. The following Amendments were submitted for review and approval:

A. Harrison County's CEFP Amendment

The Harrison County Board of Education requests approval of an amendment to its 2010–2020 CEFP. This amendment would construct a new Johnson Elementary School replacing the original renovation plan previously submitted.

Harrison County had complied with the SBA CEFP Amendment process.

B. Jackson County's CEFP Amendment

The Jackson County Board of Education requested approval of an amendment to its 2010-2020 CEFP. This amendment relocates Ravenswood Middle School onto the campus of Ravenswood High School and provides updated budget information. This plan will better serve both middle and high school students and improve the utilization of Ravenswood High School.

Jackson County had complied with the SBA CEFP Amendment process.

C. Logan County's CEFP Amendment

The Logan County Board of Education requested approval of an amendment to its 2010-2020 CEFP. Lincoln Primary Health Care, Inc. wishes to open a school based health clinic at Man Elementary/Middle School. The clinic will serve students and staff for all schools in the Man area. Minor modifications to secure an exterior entryway door are needed to access the clinic so as not to interfere with daily operations of the school.

Logan County had complied with the SBA CEFP Amendment process.

D. Pleasants County's CEFP Amendment

The Pleasants County Board of Education requests approval of an amendment to its 2010-2020 CEFP. This amendment would place a secured vestibule entrance and mantrap in the front and rear entrance of Pleasants County Middle School; also provide renovations to restrooms/locker rooms and pool area.

Pleasants County has complied with the SBA CEFP Amendment process.

E. Pocahontas County's CEFP Amendment

The Pocahontas County Board of Education requests approval of an amendment to its 2010-2020 CEFP. This amendment increases the scope of work within the existing CEFP and provides updated costs for the renovation in the current CEFP. This amendment will close Marlinton Elementary School; moving those students to Marlinton Middle School moving Marlinton Middle School 7<sup>th</sup> and 8<sup>th</sup> and Greenbank Elementary/Middle School to Pocahontas County High School. Pocahontas County High School will become 7-12 grades; Greenbank Elementary/Middle School becomes Greenbank Elementary School PK-6; and Marlinton Middle School becomes Marlinton Elementary School PK-6.

Pocahontas County has complied with the SBA CEFP Amendment process.

F. Raleigh County's CEFP Amendment

The Raleigh County Board of Education requests approval of an amendment to its 2010-2020 CEFP. This amendment increases the scope of projects and updates the costs that were in the original CEFP. This amendment would construct a new elementary school to combine the existing (or portions thereof) Lester/Crab Orchard/Sophia-Soak Creek (LCS) Elementary Schools and renovations/additions to Shady Spring High School to accommodate growing student population and significant curriculum changes proposed for this school.

Raleigh County has complied with the SBA CEFP Amendment process.

Upon a motion by Dr. William White with a second by Mr. Robert Holroyd, the Authority voted to approve all of the proposed CEFP amendments as detailed above.

**VII. FINANCE REPORTS**

A. Update of Bond Refunding

Mr. Garry Stewart informed the Authority that the refunding of the Series 2008 Bonds had moved forward the week of November 2, 2015. The final refunding results were positive and provided to the Authority.

B. Funds Available for the 2016 NEED's Projects

Mr. Stewart gave an analysis of the estimated Funds available for distribution for the 2016 NEEDs Funding Cycle and provided this information to the Authority to review in advance of the December 2015 Funding Cycle.

**VIII. PROJECT REVIEWS AND SUPERINTENDET INTERVIEWS**

The staff of the SBA has been working closely with most of the Counties submitting NEEDs Projects for funding consideration this year. The Authority was provided a summary of the projects including each project's finance plan along with staff comments relating to each project in Attachment L. Superintendents and Board Presidents were invited to present their projects to the Authority and answer questions from the Authority during this interview process.

Harrison County presented its 2016 NEEDs Project that requests SBA funds in an amount of up to \$10,778,000 and will be providing \$6,000,000, an increase of \$1,000,000 from the original plan in local funds, for a total of \$16,778,000. These funds will be used for the construction of a new Johnson Elementary on the site of the existing Johnson Elementary School.

Jackson County presented its 2016 NEEDs Project that requests SBA funds in an amount of up to \$10,212,177 and will be providing \$3,100,000 in local funds for a total of \$13,312,177. These funds would be used for a middle school addition and associated renovations to Ravenswood High School necessary to accommodate the Ravenswood Middle School enrollment. This project will replace the existing Ravenswood Middle School, which was constructed mainly as a temporary facility in 1950.

Doddridge County presented its 2016 NEEDs Project that requests SBA funding in an amount of up to \$856,875 and will be providing \$1,943,125 up to \$2,000,000 in local funds, for a total of \$2,800,000. These funds will be used for an addition of two classrooms, a multi-purpose room, and auxiliary gymnasium at Doddridge County High School.

Tucker County presented its 2016 NEEDs Project that requests SBA funds in the amount of up to \$5,171,039 and will be providing \$200,000 in local funds for a total of \$5,371,039. These funds will be used for HVAC renovations at Tucker County High School and Tucker Valley Elementary/Middle School. During their presentation, Tucker County indicated that their High School Project should be considered their first priority

Wirt County presented its 2016 NEEDs Project that requests SBA funds in an amount of up to \$2,234,107 and will be providing \$425,544 at 16% in local funds for a total of \$2,659,651. These funds will be used for Roof System replacement and exterior weatherproofing at Wirt County High School and Wirt County Primary Center and Middle School. .

Pocahontas County presented its 2016 NEEDs Project that requests SBA funds in an amount of up to \$17,885,294 and will be providing \$900,000 in local funds via a QZAB loan, if approved, for a total of \$18,785,294. These funds will be used for renovations at Marlinton Middle School and Green Bank Elementary/Middle School. Upon completion of this project, the existing Marlinton Elementary will close and students will attend the existing Marlinton Middle (5-8) in a PK-6 configuration. Additionally, Green Bank Elementary/Middle (PK-8) will be reconfigured to serve PK-6 students and all 7-8 grade students in the county will attend Pocahontas County High School. During their interview Pocahontas County indicated that its Board of Education had taken action to revise their projects financing plan to now include a \$5,000,000 local construction along with their QZAB request of \$900,000. It now proposes to provide this \$5,000,000 through a Capital Improvement Levy and to request that its project approval be contingent upon the passage of its Levy. Additionally, it purposed that if it was the pleasure of the Authority Pocahontas County would accept a Reserve Grant at this time and this would allow it the opportunity to run the Levy in May 2016 to finalize its Project Financial Plan.

Should this project be funded, the existing Collins Middle will close and students will move to the existing Oak Hill High School facility. Fayetteville and Gatewood Elementary Schools will close and students moved to the existing Fayetteville High School Facility. Anstead Elementary, Divide Elementary and Anstead Middle School will close and students will be moved to the existing Midland Trail HS facility, and Meadow Bridge High School will close. The Fayetteville, Midland Trail and Meadow Bridge facilities that are currently high schools will be reconfigured to serve grades PK-8.

Chapmanville Elementary School. West Chapmanville will house all East and West PK-1 grade students. Should this project be funded, the existing Chapmanville East Elementary will close.

Raleigh County presented its 2016 NEEDs Project that requests SBA funds in an amount of up to \$20,000,000 and will be providing \$20,815,548 in local funds, for a total of \$40,815,548. These funds will be used for a new Crab Orchard Elementary and renovations/additions to Shady Spring High School. Should this project be funded, Lester, Sophia-Soak Creek, and the existing Crab Orchard Elementary Schools will close and overcrowding at Shady Spring High School will be eliminated.

During its interview, Raleigh County indicated that an SBA multi-year financing plan would be acceptable should it receive approval of their project. It also indicated that they would immediately begin the Shady Springs High School addition and renovation as the first priority and the Educational Planning and early design phase of the new Consolidated Elementary School project would also begin but construction bidding would not occur until the financing plan is complete for the new elementary school.

This concluded the 2016 NEEDs Project Interviews.

Dr. Michael Martirano requested a report be prepared with the statistics of how the counties are keeping up with maintenance on schools that have been funded by the SBA.

Mr. Sneed indicated that this report was being prepared annually by the State Department of Education, Office of Facilities and that the staff of the SBA would contact Mr. Michael Pickens regarding the report. This report will be provided to the Authority moving forward.
